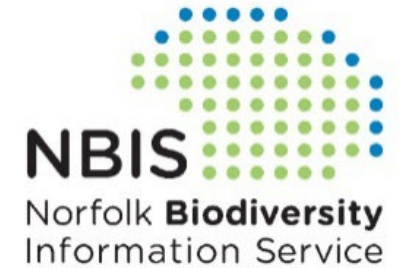

## 2. Information to note about our data

<b>Record Resolution</b>	NBIS excludes data recorded at >2km resolution from data enquiries due to poor quality of the data. Data displayed in enquires at resolution >2km, will be because the data has been blurred due to sensitive species restrictions.
<b>Date range</b>	By default, data for all years will be displayed. This can be restricted to the date range required using date filters in eMapper.
<b>Duplication</b>	Adding on a component which overlaps with the designation categories searched, such as Bats at a larger radius, would result in the same records being present on more than one tab. Another example of this is an INNS species that also belongs to one of the species designation categories. Should you need to remove this duplication it can be done using the standard output text field in the excel report, which includes the unique record identifier number within our database. This means that each standard output text is unique and can be used to identify and remove duplicates.
<b>Confidential records</b>	Any records verified as confidential, will not be included in reports. We will no longer sign post to county recorders or data owners when confidential records occur within the area of your data search.
<b>Sensitive species</b>	When an enquiry is run the enquiry type will determine if sensitive species are included at full or restricted resolution. Sensitive species restrictions will be applied in line with the NBN <a href="#">guidelines</a> and <a href="#">policy</a> on sensitive species for England. Records for all species recorded within a search area will be provided, but the resolution will be blurred in line with these guidelines, if the enquiry type requires restrictions. For commercial searches: data is provided at the recorded resolution for use by the data requester and at blurred resolution for summarised inclusion in reports. These restrictions are species specific and currently apply to 155 species. 6 species (Cattle Egret, Common Crane, Great White Egret, Honey Buzzard, Red-Backed Shrike and Golden Eagle) will be shown as the 100km square i.e., TM/ TL/TF/TG. NOTE: These records are being provided at this resolution due to blurring, not because that is the resolution that they were recorded at. We will also add additional restrictions on the advice of county recorders for specific species or groups of species as appropriate for Norfolk.
<b>Negative records</b>	Negative (absence) records will be included in results and displayed with a '-'symbol  over the record in eMapper.
<b>Data provider restrictions</b>	We will advise you of these, when they apply to your data search and may signpost you to request access to additional data.  Please note: BTO data is currently covered by data provider restrictions limiting the provision of data. Searches with a radius of 5km or greater, or a search area over100km <sup>2</sup> will not contain BTO bird data. BTO data for larger searches can be requested directly from the BTO <a href="#">HERE</a> , particularly for <a href="#">ECIA type work</a> .
<b>Bat Roost data</b>	Bat roost data will be included on the species results tabs, rather than separately. Data from clearly identified roost surveys has been identified as 'roost' in the Ecologically Important Behaviour field. It has not yet been possible to identify all bat roost records within the database, and identify them in the Ecologically Important Behaviour field, but doing so will be part of ongoing data improvements.

### 3. Information to note about our enquiry products

<p><b>Excel Report / Excel filtered report</b></p>	<p><b>What data is included?</b> The tabs shown in the Excel report are determined by the search components selected. This means that this will vary dependant on the details of the search.</p> <p><b>Species data</b> Data for international, national, local, and other species tabs (the species designation categories) will be ordered within the downloadable report based on their highest designation. Records will be displayed on the tab with the highest designation for that species. Records will not be duplicated between these four tabs.</p> <p>Where additional species tabs are included such as INNS or Bats, all records which meet this search criteria will be provided. These will duplicate data provided in the designated species tabs listed above.</p> <p><b>Sites data</b> Sites data for each designation category is summarised on a single tab, followed by a tab for each designation type present in the search area containing further details about the site.</p> <p><b>Species list</b> The species list compiles the total number of records for each designation and species search component. When a species is both in a designation category and a separate species search component, the species will appear twice on the list.</p>
<p><b>Standalone Excel species lists</b></p>	<p>Species lists contain <b>a complete list of all species found within a search area</b>. This includes sensitive species for all data request types this product is available to. Species lists also include the first and last date each species was recorded in the search area and the total number of records of the species recorded in the search area.</p>
<p><b>Citations Download</b></p>	<p><b>Citations are now provided for all designated sites where available.</b> The citation download option allows you to download all the local site citations within you search area as a PDF (when available). Internationally and nationally designated site citations are available as a link from the sites tab in the Excel report download.</p>
<p><b>eMapper</b></p>	<p>We <b>recommend taking the eMapper tour</b> found under the menu toggle, to familiarise yourself with the features of eMapper.</p> <p>Search results can be exported based on filtered criteria.</p> <p>Sites and habitat data: For larger searches we recommend turning sites and habitat data on separately. Habitat data: The Urban layer within the Living Map is turned off by default to improve usability.</p>

<b>PDF Maps</b>	Maps can be published, but only with acknowledgement of NBIS and the relevant OS and other licence statements. When printing a map, you should not release the map into the public domain unless you are printing from the public view.

#### **4. Advisory note for very large or complex data requests**

<b>Advisory note for very large or complex data requests</b>	Where a search returns an extremely large number of records, we may supply Excel and GIS files instead of eMapper access. Very large searches may need to be run without habitat data to ensure usability. Where a large search of habitat data is required, this may be provided separately as GIS files where possible. When opening large areas of habitat data in eMapper, we recommend switching on each habitat layer separately.

All records are verified, typically by the relevant County Recorder, and assigned one of the categories shown below
